To: L.T.C./F.I.D. License Applicants

Please read this informational packet prior to filling out the enclosed application, it should answer any questions you might have. Incomplete or improperly filled out applications will delay the processing of your application. When filling out the application please fill in *all information* requested and be careful to be accurate with your answers. Knowingly filing an application containing false information is a crime in Massachusetts and is grounds for denial and/or revocation of your firearm license. A thorough background investigation is conducted on all applications which include checks with the Massachusetts State Police criminal database and the Massachusetts Department of Mental Health.

Once your application has been submitted you will receive a receipt which indicates the date the licensing authority received your application. In two to three weeks after you drop off your application you will be contacted to set up a time to have your fingerprints and photograph taken. New applicants should expect the process to take up to eight weeks to receive their license, renewal applicants up to four weeks. If you have any questions you have about the licensing process call 649-7504.

As of September 17, 2004 all licenses are valid for 6 years. Licenses of those individuals who apply for a renewal before the expiration date of their current license will remain active until the application for renewal is approved or denied.

**Please note a social security number is REQUIRED on the attached form in order to process your application.

DESCRIPTION OF CLASSES OF FIREARM LICENSES

Class A License: Entitles the holder of the license to:

- Purchase, rent, lease, borrow or possess and carry: Large capacity firearms and large capacity feeding
 devices and ammunition, subject to such restrictions relative to the possession, use or carrying of
 firearms as the licensing authority deems proper.
- Purchase, rent, lease, borrow, possess and carry: **Large capacity** rifles and shotguns and feeding devices, subject to restrictions relative to the possession, use or carrying of firearms as the licensing authority deems proper.
- Violation of a restriction set by the licensing authority is a misdemeanor punishable by a fine of not less than \$1,000 or more than \$10,000.

1) Large capacity feeding device is defined as:

- a) A fixed or detachable magazine box, drum, feed strip or similar device capable of accepting, or that can be readily converted to accept, <u>more than 10 rounds</u> of ammunition or <u>more than five</u> <u>shotgun shells.</u>
- b) A large capacity ammunition feeding device as defined in the Federal Public Safety firearms Use Protection Act.

2) Large capacity weapon: any firearm, rifle or shotgun is defined as:

- a) that is semiautomatic with a fixed large capacity feeding device;
- b) that is semiautomatic and capable of accepting, or readily modifiable to accept, any detachable large capacity feeding device;
- c) that employs a rotating cylinder capable of accepting <u>more than ten rounds</u> of ammunition in a rifle or firearm and <u>more than five shotgun shells</u> in the case of a shotgun or firearm; or
- d) that is an assault weapon.

F.I.D. Cards: Entitles the holder of the license to:

- Possess non-large capacity rifles and shotguns
- Possess mace or pepper spray (18 years or older no FID required for mace or pepper spray only)

Does not entitle the holder to:

- Possess a large capacity firearm or large capacity feeding device therefore, <u>EXCEPT</u> under a Class A license issued to a shooting club as provided under section 131 or under the <u>direct supervision</u> of a holder of a Class A licenses issued to an individual under section 131 at an incorporated shooting club or licensed shooting range; <u>or</u>
- Possess a non-large capacity firearm or large capacity rifle or shotgun or large capacity feeding device
 therefore, <u>EXCEPT</u> under a Class A license issued to a shooting club as provided under section 131 or
 under the <u>direct supervision</u> of a holder of a Class A license issued to an individual under section 131
 at an incorporated shooting club or licensed shooting range.
